## A few examples of Advocacy

- **Assisting individuals to advocate for themselves.**
- **Providing information on disability issues.**
- **Making a telephone call for you, perhaps to get some information or resolve a concern.**
- **Writing a letter with you.**
- **Attending a meeting or appointment with you if you feel you need support or advice.**
- **Getting information about another agency that may be able to assist.**
- **Writing a report or submission to represent your interests.**

## Who can use this service?

Any person with any kind of disability, their family or carers can receive assistance from GdA.

The help you receive will depend upon your own needs and situation.

## What support does GdA provide?

### Individual Advocacy

### Systemic Advocacy

Systemic Advocacy is action to influence broad changes, enabling access and participation for people with a disability in the community.

### Community Education

GdA is a member of Victorian Rural Advocacy Network, Victorian Disability Advocacy Network and Disability Advocacy Network Australia.

GdA is part of the National Disability Advocacy Program funded by the Commonwealth Department of Families, Housing, Community Services and Indigenous Affairs. GdA is also funded by the Department of Human Services in the Victorian Government.

## GdA is a free service

The agency is fully funded by State and Federal Governments to provide an independent advocacy service throughout the Grampians region on behalf of people with a disability.

## GdA is Consumer Driven

You are in control at all times. The advocate will always consult you before taking any action.

## GdA is confidential

Your private information always remains yours. Only necessary information is gathered and you control who has access to this information.

If you are not happy with the service you receive from GdA you have the right to have your complaint dealt with fairly and promptly.
