### BALLARAT STATION PROGRESS UPDATE

The long battle fought by GdA's Central Highlands Region Advocacy Group (CHRAG) for improved disability access at Ballarat Station is now seeing results.


Plans have been approved to build a new disability accessible, all-weather overpass just east (Melbourne end) of what is known as the train hall and work has started on implementing those plans.

A works base is being established near Eastern Oval. The bus interchange is to be closed for all of 2025 and into 2026 (the duration of the works), with temporary bus pickup and drop off bays being established for that period in Lydiard Street North just west of the Goods Shed because the current bus interchange will close while the works are underway. This will mean that 31 car parking spaces on Lydiard Street North will be temporarily lost. There'll be new road line markings and signage to make this clear. In February, parts of the roof and walls of the southern station building to the east of the main station building and the northern station platform where it joins the bus interchange were removed to allow for the main works on the overpass to begin after February.

This work included installing temporary supports in the southern station building. We are very happy with this progress.

Of course, what's proposed is not everything we asked for or everything we'd like to see and expect. Consequently, CHRAG and GdA will continue advocating into the future for more accessibility improvements at the Station – an accessible toilet on the northern platform, adult changing

places on both platforms, sensory sensitive spaces on both platforms and second lifts on both pillars of the new overpass. Congratulations to all Involved in getting this Redevelopment this far. Let's keep it up!

### **Huge Crowds Turn Out For Midsumma Pride Despite Controversy**

Tens of thousands of people have come together today to celebrate *Midsumma Pride*, despite recent controversy surrounding the event. Members of the community joined community groups and politicians to celebrate the annual event marching the streets of Melbourne.

However the event went ahead despite police and paramedics withdrawing from the event following a uniform ban. *Midsumma* 2025 pride march kicked off being led by the *Dykes on Bikes* procession as well as *Boon Wurrung* elders and a Rainbow Aboriginal Float.

Over 7,000 marchers were accompanied by the Victorian Premier **Jacinta Allan** and Equality Minister **Vicki Ward**. "Even though it's 2025, we are seeing efforts not just to wind back the gains of equality that have been made over the past 30 years but worse, to continue to marginalise, continue to inflict hate and hurt on our LGBTIQA+ community," the Premier said.

"And I say to any right wing leader who wants to take their cues or take their notes from the MAGA movement in the USA that they have to come through me, come through the Victorian Government and come through the Victorian community first who very resoundingly stand in support of our LGBTIQA+ community." The 2025 celebration marked three decades of the event and was as vibrant as ever.

Joining the event for the first time this year was *PWDA*, <u>People with Disability Australia</u>, the national cross-disability rights and representative organisation and national peak body for LGBTQIA+ people with disability. 40 *PWDA* members marched in the event for the first time and joined over 45,000 participants for the *Midsumma Festival* celebrations.

"We march because LGBTQIA+ people with disability belong in every space – proudly, unapologetically, and with the full freedom to be themselves. Our presence at Midsumma is a powerful statement against the invisibility and exclusion that too many in our community still face," said PWDA President Trinity Ford. # Systemic Advocacy

### People in mental health crisis get healthcare, not police

Following a series of lethal interactions between police and people in mental health crisis, in 2024 JEC co-convened a panel on improving responses to mental health emergencies. After hearing from experts and family members, NSW Minister for Mental Health Rose Jackson promised to develop a framework for an alternative response to people in mental health crisis.

JEC are yet to see this framework – or any serious consultation with key community stakeholders. With allied legal, First Nations, mental health and disability organisations, JEC are urging the Minister to progress this life-saving reform and hope to see action on a health-led response soon.

### People with disability can fly in Australia without discrimination

Equal access to air travel is a step closer after the Australian Government committed to co-designing aviation-specific disability standards, which will set minimum accessibility requirements for airlines and airports.

This was a big win in 2024 and we are now calling on the Government to follow through. Together with disability advocates and disability representative organisations, JEC have highlighted the need for robust standards to address the compounding barriers people with disability face during air travel, from booking a ticket to disembarking the plane.

Co-design of the standards should begin in the first half of 2025 and JEC will take an active role in ensuring the process is genuine, transparent and rigorous.

### **Qantas Changes Policy for Assistance Dogs on Flights**

November 14, 2024

After more than 2 year-battle, Qantas will now change its processes to make it easier for people to travel with assistance dogs.

In 2022, Qantas refused to let passenger Rachael Fullerton fly with her assistance dog, Strike, claiming he did not meet the airline's particular requirements for assistance dogs. Strike is trained to do several tasks including getting medical help as well as providing physical and psychological support.

Rachael Fullerton was determined to fight Qantas on this issue so others wouldn't face the same discrimination. <u>Justice and Equity Centre</u> took on the case arguing it was disability discrimination as the airline's previous policy on assistance dogs was too narrow for the requirements mentioned in the Disability Discrimination Act.

## Qantas to improve assistance dog processes after discrimination case

### Excerpt from Nine News:

A Sydney woman has settled a discrimination case against Qantas after the airline refused to let her fly with her assistance dog.

Rachael Fullerton, who lives with a disability, was denied permission to travel with her assistance dog Strike in 2022.

Fullerton said although the changes were "well overdue", the result will make a huge difference for people who rely on assistance dogs to travel independently.

"It's inconceivable that people with disabilities are still facing so many barriers to service, but hopefully this will set a precedent for improved disability standards and better practices from many businesses moving forwards," she said.

# NDIS NEWS CEO statement: listening to the community - eligibility reassessments

### 3 February 2025

At the National Disability Insurance Agency (NDIA), they are genuinely committed to listening and responding to the voices of people with disability.

This is vital to their goal of getting the right outcomes and supporting the welfare of every NDIS participant. Recently, they've heard feedback and concerns about their process for eligibility reassessments.

These assessments help them understand if a participant's support needs have changed and whether they still meet the eligibility criteria for the Scheme.

They've heard from both representatives in the disability sector as well as participants who are undergoing reassessments. They understand that eligibility reassessments can be stressful and feel overwhelming, their current communications can be confusing and 28 days is not long enough to gather information.

They're responding to these concerns by making some immediate changes to improve this process, and they will keep working in coming months to improve communications and the experience for participants and their families.

From today, participants will now have more time to get information to them. They have extended the timeframe for participants to provide additional information to support eligibility reassessments from 28 to 90 days.

They're also working to provide greater clarity through better communication and resources for participants and families about what is involved during an eligibility reassessment. This work involves listening directly to participants and the disability sector about ways they can improve their communications and ensure people can feel as supported as possible.

Work is already well underway and is expected to be finalised in March 2025.

While eligibility reassessments have always been a part of the NDIS, they know the experience is likely to be a new one for most participants. This means the process can make people feel stressed or unsure. For some participants, their support needs won't change. For others, they may reduce over time.

No matter a participant's circumstances, they want them to feel supported in every interaction they have with the NDIA. That's why they are committed to always improving the ways they work.


# Independent Advisory Council releases 2023-24 Annual Report

They are the voice of the participants at the highest level, bringing skills, expertise and knowledge that will help the IAC perform its function.

### NDIS CHANGES YOU NEED TO KNOW ABOUT

From 3 October 2024, participants and their authorised representatives:

- can only spend NDIS funding on things that are in the approved list of NDIS supports
- cannot spend NDIS funding on things in the list of non-NDIS supports.

# Eligibility Reassessment

Participants (or nominees) will receive a letter explaining eligibility reassessments and any required information.

Under new laws, the NDIS may request specific details, such as:

- A particular type of assessment.
- A report from an allied health professional.

Participants have **90 days** to provide the information, with extensions available if needed.

While no specific requests have been made yet, if the NDIS do ask, the NDIS will support participants to understand what is needed, why, and by when.

If someone **doesn't** respond within the timeframe or is found ineligible, their NDIS access may be revoked to ensure support is directed where it's needed most.

Mandatory eligibility reassessments will apply in some cases, such as when children turn 9.
